Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The Pre-Bid Conference is scheduled on January 19, 2021 at 10:00 AM at the DASURECO Hilltop Gym, Main Office, Barangay Cogon, Digos City which shall be open to prospective bidders.
4. Pursuant to the Proclamation No. 1021 and STRICT implementation of social distancing due to the Covid19 pandemic, the Procurement Service is equipped with a facility that uses **video conferencing facilities** to continuously communicate and collaborate with stakeholders.
- All interested parties may access the Pre-Bid Video Conference call through a link which shall be provided directly to your email. Potential bidders who access the link shall be required to input their attendance, name, representation, and contact details as normally required in physical meeting.
5. **Bidding proper and Opening of Bids shall be on February 18, 2021** at 10 o'clock in the morning, venue at DASURECO Hilltop Gym, Main Office, Barangay Cogon, Digos City.

Bidding Documents can be purchased at BAC Secretariat, CPD Building, DASURECO Main Office, Cogon, Digos City from January 10, 2021 up to February 17, 2021. **Only those who have purchased the Bidding Documents amounting to Five Thousand Pesos Only (Php5,000.00) for Lot 1; Lot 2; and Lot 3; Ten Thousand Pesos Only (Php10,000.00) for Lot 4; Twenty-Five Thousand Pesos Only (Php25,000.00) for Lot 5; and Fifty Thousand Pesos Only (Php50,000.00) for Lot 6, non refundable shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarification.**
